All were in favor with one abstention. The Motion was carried.

Second Vice Chair Committee Appointment:

The Chair advised of the currently vacant Vice Chair seat and its reappointment. He selected a nominating committee comprised of Ms. Beverly Bond, Mr. Walter Harris and Ms. Mildred James with Ms. Bond to Chair said committee. The Board is to vote in March on their recommendations.

Presentation of New York Yankees Scholarship Awards:

Presentation: U.L.U.R.P. Application # C 130064 ZMX regarding 580 Gerard Avenue by Ms. Jennifer Dickson, Representative of Herrick, Feinstein LLP.

An U.L.U.R.P. application has been submitted to the Department of City Planning for a proposed re-zoning of 580 Gerard Avenue from a manufacturing zone to a R7A residential zoning district. The site is a 147,000 square foot building with 24,000 square feet dedicated to retail space. The building will consist of 124 total residential units. Currently it is being used as a storage facility. It will include an inclusionary tax amendment which allows for a larger building. The current Floor Area Ratio (FAR) is 3:45 and owner is seeking a 4.6 FAR to get a larger building. 20% of the units (24 apartments) will be affordable. A studio will be \$950; one bedroom \$1180, two bedroom \$1425 and three bedroom \$1580. These rates can be lower dependent on which program is used to finance. Marketing units will be: studios - \$1000; one bedroom - \$1200-\$1300; two bedroom -\$1500-\$1600 and three bedrooms - \$1700-\$1800. An underground parking lot will be available for 50 % of the residents only. 50% of the units will be allocated to Community Board 4 residents. The application is for re-zoning from a manufacturing to residential district. The U.L.U.R.P. process takes 60 days. If it is the Board's request to make changes to the proposed site/building, the presenters will have to come back to committee. However, because it is private land, they do not have to come back. Under the Inclusionary Program, the owner will get a bonus only if affordable units are created at a minimum of 20% of units. Motion was made by Bishop Earl McKay for a letter of support for U.L.U.R.P. application #C 130064 ZMX re-zoning of 580 Gerard Avenue from manufacturing to residential and seconded by Mr. Barry Nissen. All in favor except for one abstention.
