If you believe that the amount of your bill is wrong, you can send a written complaint to the NYC Water Board at 59-17 Junction Boulevard, 8th Floor, Flushing, NY 11373. The NYC Water Board must receive your written complaint by _____.

You may be eligible to stop the water shut off if you have a serious medical condition, are elderly, blind, or disabled, or have children under 6 years old living in the household.
