## NYC VCP Cleanup Plan Remedial Activities to Begin

The New York City Office of Environmental Remediation (OER) is providing this Fact Sheet pursuant to the New York City Voluntary Cleanup Program (VCP). OER has approved the Remedial Action Work Plan (RAWP) submitted by 338 West, LLC for 334-338 West 36<sup>th</sup> Street, New York, New York (Block 759, Lot 61). The remedial work will begin in April 2016. The RAWP can be reviewed electronically or in person at the document repositories identified in the box at left.

### Site Description:

The 12,344 square-foot site is currently a vacant lot. The proposed use of the site is a new 28-story hotel tower.

### Summary of the Remedy:

The remedial action for 334-338 West 36<sup>th</sup> Street is a Track 4 Site-specific Use cleanup. The specific elements of the proposed remedial action include:

- Preparation of a Community Protection Statement and performance of all required NYC VCP citizen participation activities according to an approved Citizen Participation Plan;
- Performance of a Community Air Monitoring Program for particulates and volatile organic carbon compounds;
- Establishment of Track 4 Site-Specific Soil Cleanup Objectives (SCOs);
- Excavation and removal of soil/fill in excess of SCOs. Approximately, 300 tons of soils will be excavated and removed from this property.
- Transportation and off-site disposal of all soil/fill material at permitted facilities in accordance with applicable laws and regulations;
- Implementation of storm-water pollution prevention measures in compliance with applicable laws and regulations;
- Collection and analysis of end-point samples to determine if the remedy attains Track 4 SCOs;
- Installation of a vapor barrier system beneath the building slabs and on the inside of the sub-grade foundation sidewalls of the proposed building;
- Construction and maintenance of an engineered composite cover consisting of 6" concrete slab in the open spaces to the north and south of building, 6" concrete slab beneath all building areas and 2 feet 6 inches concrete slab beneath elevators pit to prevent human exposure to residual soil/fill remaining under the site;
- Submission of a Remedial Action Report (RAR) that describes the remedial activities and certifies that the remedial requirements have been achieved and lists any changes from this RAWP;
- Submission of an approved Site Management Plan (SMP) in the RAR for long-term management of residual contamination, including plans for maintenance, inspection and certification of Engineering and Institutional Controls and reporting at a specified frequency; and
- Continued registration with E-designation for the property.

Cleanup activities are scheduled to begin in April 2016 and are expected take approximately three months to complete.

**Next Steps:** After the enrollee completes the remedial work, a RAR will be prepared and submitted to OER. The RAR will describe the cleanup activities and certify that all cleanup requirements were met. Once the RAR is approved, OER will issue a Notice of Completion, a City liability release, and a New York City Green Property Certificate. OER will then issue a fact sheet announcing the completion of the remedial action and identify all engineering and institutional controls to be used at the Site.


