Committee had an informal meeting with Mr. Cocola.

NEW BUSINESS:

Community Complaint # 55181 – Amboy Road between Richmond Valley Road and Bedell Avenue. Complainant states numerous accidents at this location occur in this dangerous stretch of roadway. Suggests a study to make traffic safety/speed zone with additional signage/traffic controls/lane markings. Committee requests traffic study.

Community Complaint # 55193 – Ramona Ave at the corner of Vernon Avenue. Complainant requests an additional STOP Sign on Ramona to make it an All Way Stop. Committee recommends Stop sign.

Community Complaint # 55197 – adjacent to 53 Ainsworth Avenue at the corner of O’Gorman Avenue. Resident requests No Parking or No Standing signs to daylight the corner to improve view for oncoming traffic coming up O’Gorman from Hylan Blvd. Committee feels this is not necessary; there are no obstructions at intersection which impedes vision of oncoming traffic.

Community Complaint # 55198 – Lenevar Avenue between Woodrow Road and Drumgoole Road West. Resident wants addition controls at the location to slow down traffic. Speeding is a

problem in this residential area near Bloomingdale Park. Committee reviewed and states there are stop signs on Lenevar Avenue between Woodrow & Ramona Avenue. Lenevar Avenue from Ramona Avenue to Drumgoole Road West is designated as a New York State, Department of Motor Vehicles Road Test Area. Committee cannot impede with this designated test area. There is adequate signage on cross streets into Lenevar Avenue

Community Complaint # 55208 – Rathbun Ave/ Huguenot Avenue. Resident requests traffic signal at location. Committee reviewed and there is a traffic signal in close proximity to this location.

Community Complaint # 55214 – Corner of Bloomingdale Road & Woodrow Road. Resident requests that the right turn on red sign be removed. Committee will recommend that DOT daylight the corner and to install a designated lane to make the right turn on Red.
