### TLC DIRECTIVE: ATTENDANCE MANDATORY AT STRIKE PLAN MEETING TO BE HELD WEDNESDAY, DECEMBER 11 at 10 A.M.

The New York City Taxi and Limousine Commission (TLC) will hold an EMERGENCY TRANSIT STRIKE CONTINGENCY PLAN meeting on Wednesday, December 11, at 10:00 AM. Attendance is MANDATORY for all For-Hire Vehicle base owners, Medallion Agents, and Commuter Van authorities. Managers and/or Principals with decision-making authority must be present on behalf of each business in attendance. This mandatory meeting will take place at:

- **The MAIN STAGE THEATER, Building E, Room 243 of LaGuardia Community College, located at Van Dam Street and 47th Avenue in Long Island City, Queens.**
- **Failure to attend this mandatory meeting will result in the issuance of a summons and/or license suspension for non-compliance. This shall serve as an official Agency Directive.**
- **All For-Hire Vehicle base representatives MUST bring their current rate of fare books as well as a current vehicle inventory list (including seating capacity).**

Pursuant to TLC Industry Notices #02-17 and #02-19 (July 2002), all For-Hire Vehicle bases must be in compliance with NYC TLC For-Hire Vehicle Rule § 6-08(c), which states that each For-Hire Vehicle base station owner is responsible for filing with the TLC, on an annual basis, or whenever there is a material change, the schedule of the rates of fare charged by that base. Those bases that are found to not be in compliance with the TLC's directive to file rates of fare will be subject to additional enforcement action. All those For-Hire Vehicle bases that have filed rates of fare are reminded that they must charge passengers in accordance with these posted rates, or face enforcement action.
